Baseline Emissions Footprint

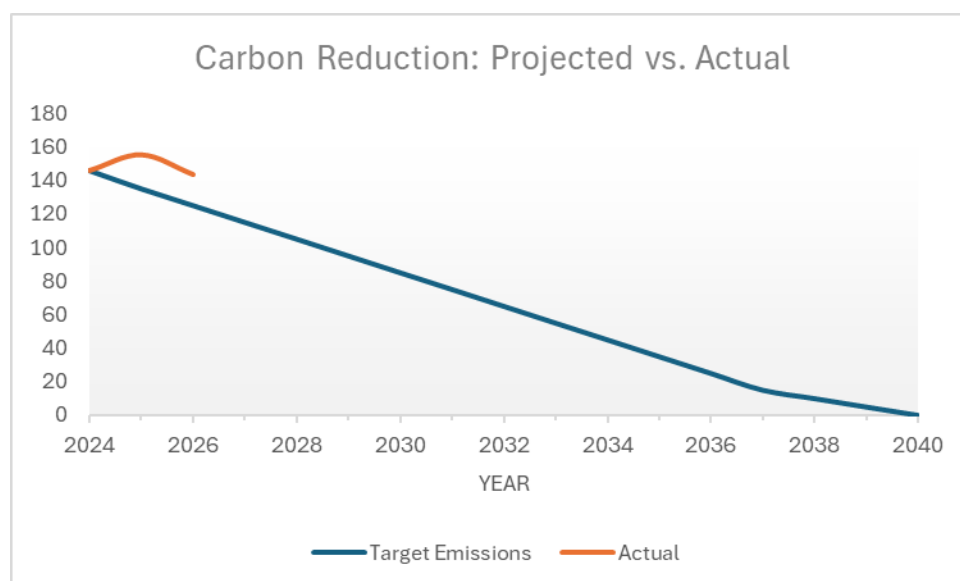

Progress against these targets can be seen in the graph below:



The 2025–2026 emissions can be presented as intensity indicator of 65.34 tCO₂e per million GBP £. This compares to 77.44 tCO₂e per million GBP £ in 2024–2025.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The company installed solar panels and two EV chargers prior to the baseline reporting. The solar panels generate ~10,000kWh of energy per year which is used to power the building and charge electric vehicles.

The company have maintained ISO 14001 certification since September 2009.

The following environmental management measures and projects have been completed or implemented since the 2023-2024 baseline: -

- Installation of LED lights throughout the main office areas, stores, kitchen and corridors of the head office building.
- Lagging of hot water pipework to laboratory, kitchens and male/female toilets.

The following environmental management measures and projects have been completed or implemented since the 2024-2025 reporting:-

- Installation of LED lights to other areas (workshop, toilets and laboratories) of the premises.

The measures will be in effect when performing the contract.

In the future we hope to implement further measures such as:

- Replacement of company vehicles with plug in hybrid vehicles and electric vehicles.
- Installation of additional 36 solar panels to power our own battery storage.
- Installation of 2 further EV chargers.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.
